The officers and members of the Chapter first visited the Tahanang Mapagpala II last July 12, 2020.




e-SIPAT'TUKLAS: BSAs Rising With CPAs


Finally, in what is becoming a tradition, the NMMC treated the participants and the new members to a fun-filled day with games, surprises and raffle prizes.
